- The School shall admit in class I, to the extent of 25 % of the strength of that class, children belonging to weaker section and disadvantaged group in the neighborhood and provide free and compulsory elementary education till its completion.

Provided, that in case of pre primary classes also, this norm shall be followed.

- For the children referred to in paragraph 3, the School shall be reimbursed as per Section 12 (2) of the Act. To receive such reimbursements school shall provide a separate bank account
- The Society/School shall not collect any capitation fee and subject the child or his or her parents or guardians to any screening procedure. MEDICAL PROJECTION
- The School shall not deny admission-6.
 - To any child for lack of age proof.
 - If such admission is sought subsequent to the extended period prescribed for admission. b)
 - On the ground of religion, caste or race, place of birth or any of them.
- The School shall ensure that:
 - No child admitted shall be held back in any class or expelled from school till the completion of elementary education in a school;
 - No child shall be subjected to physical punishment or mental harassment;
- No child is required to pass any board examination till the completion of elementary ___ c) education;
 - Every child completing elementary education shall be awarded a certificate as laid down d) under Rule 21,
 - Inclusion of Students with disabilities/special needs as per provision of the Act; The teachers are recruited with minimum qualifications and are provided with minimum e)

- The School is not run for profit to any individual, group or association of individuals or any other persons;
- 15. The accounts should be audited and certified by a Chartered Accountant and proper accounts statements should be prepared as per rules. A copy each of the Statements of Accounts should be sent to the District Education Officer, Elementary and Secondary every year.
- 16. The recognition Code Number allotted to your school is SSA/BTI/RTE/536 (This may please be noted and quoted for any correspondence with this office)
- 17. The school furnishes such reports and information as may be required by the Department of Education/District Education Officer/Block Primary Education Officer from time to time and complies with such instructions of the State Government/ Local Authority as may be issued to secure the continued fulfillment of the condition of recognition or the removal of deficiencies in working of the school;
- 18. School will ensure the renewal of Building Safety Certificate and Fire Safety Certificate every year and provide attested copies to District Education Officer (E.E.) at the beginning of every new session. If the school does not provide these two renewed certificates (building safety and fire safety) then necessary action will be taken to cancel the recognition according to RTE Act.
- 19. School will ensure that School Vans/Buses are complying the norms and standards of Safe School Vahan Scheme.
- 20. Renewal of Registration of Society if any, be ensured.
